



PROCEEDINGS OF THE STATE LEVEL TECHNICAL COMMITTEE (SLTC) MEETING For Special SLTC 2024-25 (2nd PHASE) held on 12.09.2025 at 01:00 PM in the 1st Floor Board Room of Krushi Bhawan, Bhubaneswar

The State level Technical Committee (SLTC) meeting for the Special SLTC (2024-25) 2nd phase for empanelment/approval of manufacturers along with make & model of implements, equipment and machineries relating to Agriculture, Fisheries & Animal Resources Development sector was held under the Chairmanship of the Director, Agriculture & Food Production, Odisha, Bhubaneswar in the 1st floor board room of Krushi Bhavan at 1.00 PM on 12.09.2025. The members attended is enclosed at **Annexure – 1**.

The Chief Engineer (Agril.) welcomed the participants and briefed the committee on the agenda for discussion in the Special SLTC 2024-25 (2nd Phase). The Development Engineer in his presentation mentioned that the 28 manufacturers whose 98 make and models were rejected in SLTC 2024-25 (2nd Phase) were given a window from 07.08.2025 to 22.08.2025 to resubmit and comply with the stated objections. During this compliance window, a total of 45 make and models of agricultural implements were applied by 15 manufacturers for empanelment through the online portal under Special SLTC 2024-25 (2nd Phase).

The Technical Scrutiny Committee (TSC) was held under the chairmanship of Chief Engineer (Agril) on dated 06-09-2025 for scrutiny and recommendation of models for approval in the Special SLTC 2024-25 (2nd Phase). The recommendations of the TSC are detailed below.

- 31 numbers of makes and models were recommended for approval in the Special SLTC (2024-25) 2nd phase
- 17 numbers of makes and models were not recommended for approval as these could not comply requisite documents in proper format.
- The Committee also recommended following corrections/updation in make & model of two implements approved in previous SLTC due to inadvertent error at SLTC level,

After a threadbare discussion among the members, the following decisions are made in SLTC;

- 31 numbers of makes and models recommended for approval by TSC are approved
- 17 numbers of makes and models are not approved as these could not comply requisite documents in proper format.

- The manufacturers whose models are rejected shall be intimated through SMS/Email, along with the specific reasons for rejection.
- The SLTC approved corrections in make & model of two implements recommended by TSC as mentioned below.
